

Fall 2015 Admitted, Not Enrolled Report

Analysis of Subsequent Enrollment of Fall 2015 First-Year Admits

Executive Summary

During the fall 2015 application cycle, the University of Illinois at Chicago (UIC) experienced a record number of 16,338 first-year applications, that resulted in 12,082 admits. A total of 3,485 first-year students enrolled in the fall term, thus indicating a yield rate of 29% (admit to enroll rate). The yield rate in 2014 was 26%. There were approximately 7,250 first-year students admitted to UIC, who had subsequent enrollment at other postsecondary institutions. This report indicates the subsequent enrollment of this group of students, verified through the National Student Clearinghouse (NSC) Student Tracker service. This service provides information regarding (a) if an admitted student who did not enroll at UIC, enrolled at a postsecondary institution, and (b) the institution of enrollment.

NSC returned 7,250 subsequent enrollment records, reflecting approximately 85% of the admitted, not enrolled student population. Thirteen percent of the ANE records indicated enrollment in a 2-year institution, which showed an increase over the past two years (10% in 2014 and 11% in 2013). Sixty-one percent of ANE records indicated enrollment at an Illinois institution.

Methods

Student records from the admitted population and enrolled population were extracted from application and registration databases. The first-year application, admit, and enroll pool is shown in Table 1, disaggregated by UIC college of application and Race/Ethnicity. The average ACT composite score and average high school grade point average (GPA) is also shown.

The Admit Not Enroll (ANE) pool is comprised of approximately 8,500 students (unduplicated head count), who were admitted to UIC but did not enroll. A request for enrollment records was submitted to the NSC Student Tracker service in January 2016. A total of 7,958 usable student records were returned, which included students with multiple enrollments. Appendix A details the timing of this report and the established criteria to handle records of multiple enrollment. There were no NSC enrollment records for 1,149 students, and 47 were blocked from distribution. Students whose only enrollment record reflected a withdrawal from enrollment were not considered in this analysis. This established criteria resulted in 7,250 unique student records.



Results

The National Student Clearinghouse provided subsequent enrollment for 7,250 first-year students who were admitted to UIC, but did not enroll in the fall 2015 term. A total of 662 institutions were included in the subsequent enrollment file. Eighty-seven percent of the students were enrolled at fouryear institutions, and 13% of the students were enrolled at two-year institutions. This year, there was 23% increase of subsequent enrollment at 2-year institutions (751 students enrolled at two-year institutions in fall 2014). Table 2 displays the number of enrolled students by institution type, disaggregating the number of students enrolled in an Illinois institution. Sixty-one percent of the ANE students enrolled in an Illinois postsecondary institution.

Overall, 85% of the ANE pool is reflected in this report. Table 3 displays the count and percent of total of ANE records disaggregated by UIC college of admission. Consistent with size, approximately 65% of subsequent enrollment records belong to LAS admits. Table 4 provides data on the top 35 institutions of subsequent enrollment, as a total count and disaggregated by the UIC college of admission. Due to the large differences between ANE record counts (refer to Table 3), the college data in Table 4 are presented as percentages of total ANE records with respect to each college.

Although the ANE counts vary by college, it is noteworthy that the percent of ANE records of the whole ANE pool is somewhat consistent across colleges (range: 79% - 90%). For example, 90% of admitted not enrolled students from the College of Applied Health Sciences (AHS) are represented in this report; meaning there were no records of subsequent enrollment for only 10% of admits from AHS (28 students).

Table 5 displays the top rankings for fall 2015, in comparison to the prior three fall terms. The top 10 institutions of subsequent enrollment are mostly consistent with prior years. However, this year there was an increase in the number of students who attended College of DuPage, Purdue University and the University of Iowa and a decrease in students who attended Marquette University. Worth noting is the 58% increase in enrollment at Purdue University over the last four years (72 students in 2012, 114 students in 2015).

Table 6 displays the comparison among the top 20 institutions for fall 2015 and fall 2014. The top 20 institutions account for 51% of the fall 2015 subsequent enrollment records. The change in enrollment count range from -46 (a decrease of 46 students in fall 2015 enrollment at Loyola University) to +187 (an increase of 187 students in fall 2015 at University of Illinois at Urbana-Champaign). The percent range is minimal, with respect to the size of the ANE pool; University of Illinois at Urbana-Champaign showing a 2.6% increase in enrollment, and DePaul University and Loyola University both showing a 1% decrease in subsequent enrollment.

Of the top 20 institutions, eight are 4-year public institutions, seven are 4-year private institutions, and five are 2-year public institutions. Additionally, this year the top 20 institutions include two of the seven City Colleges of Chicago. Thirteen of the top 20 institutions are located in Illinois; the remaining seven institutions are located in states that border Illinois.

Student Demographics and Background Characteristics

Race/Ethnicity

Table 7 indicates the number of records supplied by the National Student Clearinghouse disaggregated by race/ethnicity. Fifty-eight percent of the ANE records are female students, which is slightly greater than that of the admitted, not enrolled population (57%). Table 7 also indicates the percent of ANE records with respect to each race/ethnicity.

Residency

Tables 13 through 15 display the top institutions by residency code for tuition purposes: in-state residents, out-of-state residents, and international residents. Tables 13 and 15 display 12 institutions to account for 51% of the total records for in-state residents and 45% of the total records for international residents, respectively. Table 14 displays the top 20 institutions in order to supply 29% of the total records for out-of-state residents, indicating much more variation in the institution of subsequent enrollment. For out-of-state residents, 422 institutions have enrollment of five or less. Unlike in-state residents, out-of-state students reside in other states and ultimately enroll in institutions located in other states.

Seventy-four percent of In-State residents, 12% of out-of-state residents, and 10% of International students enrolled in Illinois institutions. The University of Illinois at Urbana-Champaign continues to be a top competitor, attracting 19% of in-state residents who were admitted to UIC. Furthermore, 98% of the Urbana students in this report are Illinois residents.

Highly qualified students are defined as students who score a 28 or higher on the ACT, or earn a high school GPA of 3.7 or greater. **Table 16** details the most frequently attended institutions for the 29% of students who scored at least a 28 on the ACT (N=2,131) and the 25% of students who earned a GPA of at least a 3.7 in high school (N=1,817). The list of institutions is in order by frequency of ACT score. Nine hundred six students are accounted for in both columns due to meeting both criteria, however the list of most frequently attended institutions is similar to the following table.

Appendix A

Report Timing

The data from this report were received from NSC in early January. In previous years, the data were submitted and received earlier; however it was apparent that some institutions on quarter academic calendars were not included in the files returned due to different reporting deadlines. Thus, the timing of this report was delayed in order to account for institutions that utilize quarterly academic schedules. A prime example of this is the inclusion of Northwestern University in Table 16. Last year, the data indicated that less than five ANE students attended Northwestern University, however only data from the summer were returned from NSC.

Constructing the Data Set

In the NSC response file, 253 records (122 unique student records) reflected multiple institutions of enrollment. The criteria established to handle these records are as follows.

- (a) If the enrollments were chronological (i.e., summer and fall enrollment), the fall term institution was used over the summer term enrollment institution.
- (b) If concurrent enrollment reflected a part-time and full-time attendance, the institution of full-time attendance was used.
- (c) If concurrent enrollment reflected a two-year and four-year institution, the four-year institution was used.
