Subsequent Enrollment Analysis of Fall 2016 First Year Admitted Students

Executive Summary

During the fall 2016 application cycle, the University of Illinois at Chicago (UIC) received 18,725 first-year applications that resulted in 13,209 admits (71% admit rate). A total of 3,307 first-year students enrolled in the fall term, translating to a yield (admit to enroll) rate of 25%, down from 29% in 2015 and 26% in 2014. There were approximately 9,891 first-year students admitted to UIC who did not enroll at UIC. This report provides information on the fall enrollment status of students who were admitted but did not enroll at UIC.

The National Student Clearinghouse (NSC) Student Tracker service was used to verify subsequent enrollment of the admitted and not enrolled (ANE) students. This service provides information regarding (a) if an admitted student who did not enroll at UIC enrolled at a postsecondary institution, and (b) the institution of subsequent enrollment. NSC returned 8,653 subsequent enrollment records, reflecting approximately 87% of the admitted and not enrolled student population. Twelve percent (N=1,077) of the ANE records indicated enrollment in a 2-year institution. Fifty-nine percent (N=5,085) of ANE records indicated enrollment at an Illinois institution. Disaggregated detail is provided by college, race and ethnicity, residency, highly qualified admits and the 379 admits whose last correspondence with UIC was a declared Intent to Enroll.

Results

Student records from the admitted population and enrolled population were extracted from application and registration databases. The first-year application, admit and enroll pool is shown in **Table 1**, disaggregated by Race/Ethnicity and UIC college with the average ACT composite and high school GPA.

The ANE pool is comprised of approximately 9,900 students who were admitted to UIC but did not enroll. **Table 2** reports the ANE population by college of admission and race/ethnicity.

A request for enrollment records of the ANE population was submitted to the NSC Student Tracker service in October 2016. A total of 8,708 usable student records were returned, which included students with multiple enrollments. Appendix A details the criteria to handle records of multiple enrollment. There were no NSC enrollment records for 1,181 students, and 42 were blocked from distribution. Students whose only enrollment record reflected a withdrawal from enrollment were not considered in this analysis. This established criteria resulted in 8,626 unique student records.

The National Student Clearinghouse provided subsequent enrollment for 8,626 first-year students who were admitted to UIC but did not enroll in the fall 2016 term. A total of 740 institutions were included in the subsequent enrollment file. Eighty-eight percent of the students were enrolled at four-year institutions, and 12% of the students were enrolled at two-year institutions. Of the 7,555 students at 4-year institutions, 52% were at public institutions. Table 3 displays the number of enrolled students by institution type, disaggregating the institution control. Sixty-one percent of the ANE students enrolled in an Illinois postsecondary institution.

Overall the ANE population increased by 1,308 (15%) from 2015, the NSC records returned with subsequent enrollment increase by 1,376 (19%). The proportion of students enrolled in 2-year institutions decreased slightly from 13% (in 2015) to 12% (in 2016) and the proportion at private institutions remained constant at 42%.

Table 4 provides data on the top 35 institutions of subsequent enrollment as a total count and disaggregated by the UIC college of admission. Due to the large differences between total number of ANE and subsequent enrollment record counts, the college data in **Table 3** are presented as percentages of total ANE records **for each college**. For example, the 1,360 students enrolled at UIUC represent 15.8% of the total subsequent enrollments (n=8,626). For CBA, the enrollment at UIUC represents 13.5% of the 918 total subsequent enrollments; for Engineering, UIUC enrollment represented 25.9% of the 1,202 subsequent enrollments.

Table 5 displays the top rankings for fall 2015, in comparison to 2015 and 2014. The top 5 institutions of subsequent enrollment are consistent with prior years. Notably, DePaul University has surpassed Loyola University of Chicago to the second largest institution of subsequent enrollment.

Table 6 displays the comparison among the top 20 institutions for fall 2016 and fall 2015. The top 20 institutions account for 50% of the fall 2016 subsequent enrollment records. The percentage reported represents the proportion of the subsequent enrollment total enrolled at each institution. For example, the 1,360 students enrolled at UIUC in 2016 is 15.8% of the subsequent enrollment total of 8,626; in 2015 the 1,097 students represented 15.1% of the subsequent enrollment total. The change in enrollment count range from -49 (a decrease of 49 students in fall 2016 enrollment at Northern Illinois University) to +263 (an increase of 263 students in fall 2016 at UIUC). Of the top 20 institutions, seven are 4-year public institutions, eight are 4-year private institutions, and five are 2-year public institutions. Additionally, this year the top 20 institutions include two of the seven City Colleges of Chicago. Fifteen of the top 20 institutions are located in Illinois.

Race and Ethnicity Comparisons

Tables 7 - 10 show the 12 most frequently attended institutions by Asian students, Black/African American students, Hispanic students, and White students, respectively with a previous year comparison group where available. These tables provide snapshot views and the similarities and differences between the competitor institutions based on race/ethnicity. For example:

- There are no 2-year institutions among the top 12 for African American students while the number is three, four and two for Asian, Hispanic and White students respectively.
- The number of private institutions represented in the lists are six for Asian students, three for African American and five for White and Hispanic students.
- The top 12 list covers only 40% of the African American subsequent enrollments. The proportion is 41%, 48% and 57% for Hispanic, White and Asian students respectively. This means that African American enrollments are spread across larger number of institutions (n=270) relative to the ANE population (n=960). In contrast, there are 1,770 Asian ANE students enrolled at 261 institutions.

Residency Comparisons

Tables 11 through 13 display the top institutions by residency code for tuition purposes: in-state residents, out-of-state residents, and International residents. **Tables 11 and 13** display 12 institutions that account for 52% of the total records for in-state residents and 38% of the total records for international residents. Table 12 reports the top 20 institutions attended by domestic non-resident students. The top 20 institutions for domestic out-of-state residents represent 31% of the total records, which indicates much more variation in subsequent enrollment compared to in-state residents and International residents. Of the 1,360 ANE students enrolled at UIUC, 92% are Illinois residents, 7% domestic, non-resident and 1% International students.

Highly Qualified Students

Highly qualified students are defined as students who score a 28 or higher on the ACT, or earn a high school GPA of 3.7 or greater. The total ANE pool included 2,572 students with a HS GPA of at least 3.7 and 2,878 students with an ACT composite of 28 or above. The total number of ANE students with both a 3.7 plus HSGPA <u>and</u> an ACT of 28 or better is 1,196. There were 1,065 NSC subsequent enrollment records for this group. **Table 14** details the twelve most frequently attended institutions for these students, which represents 51% of the total number of subsequent enrollments.

Declared Intent to Enroll but Did Not Enroll Detail

A final group of ANE students was disaggregated for examination this year. There were 379 students whose last correspondence with UIC was a declaration of Intent to Enroll (ITE) who did not enroll in the fall term. Of this 379, 157 (41%) did not have a record of subsequent enrollment. Table 15 represents the top ten institutions of enrollment of the 222 students with NSC record of enrollment. This list which includes six 2-year institutions represents 44% of all the students with subsequent enrollment records.

Appendix A

CONSTRUCTING THE DATA SET

The data from this report were received from NSC in mid-October. In instances where the NSC response file reflected multiple institutions of enrollment, the criteria established to handle these records are as follows. (a) If the enrollments were chronological (i.e., summer and fall enrollment), the fall term institution was used over the summer term enrollment institution. (b) If concurrent enrollment reflected a part-time and full-time attendance, the institution of fulltime attendance was used. (c) If concurrent enrollment reflected a two-year and four-year institution, the four-year institution was used.
